Subject: Notification of the Reestablishment of the United States of America Republic as the Free National Government of the Moorish American People

#### Excellency,

- 1. I have the honor to notify the Secretariat that the Moorish American People identified herein as Indigenous and Aboriginal Peoples of America are represented through the United States of America Republic National Government (U.S.A.R.), which has undertaken the re-establishment and reactivation of its free national government and institutions.
- 2. This notification is grounded in inherent sovereignty and is further supported by historical treaty relations and principles of international law, including self-determination and the rights of Indigenous Peoples.
- **3.** Pursuant to Articles 1(2) and 55 of the Charter of the United Nations; the United Nations Declaration on the Rights of Indigenous Peoples; and the framework of the

Vienna Convention on the Law of Treaties, we respectfully request that this communication be entered into the records of the United Nations.

**4.** Enclosed please find an Executive Summary (Annex A). The U.S.A.R. stands ready to provide additional annexes, including a memorandum of law, historical instruments, and evidence of current institutions, upon request.

#### **Annex A - Executive Summary**

#### Title:

Reestablishment of the United States of America Republic as the Free National Government of the Moorish American People

#### Purpose:

To restore the lawful governance structures of the Moorish American People, consistent with historical instruments, the U.S. Constitution and the Constitution of the United States of America Republic, and international law.

#### Legal Basis:

- 1. Treaty relations historically referenced between the United States and Morocco (Treaty of Peace and Friendship 1786, renewed 1836). Art. 15 Treaty of Madrid (1880)
- 2. U.S. Constitution, Article VI (Supremacy Clause). U.S. Constitution, Article IV (Guarantee every state a republic form of government)
- 3. United Nations Declaration on the Rights of Indigenous Peoples; ILO Convention No. 169; Vienna Convention on the Law of Treaties.

#### **Objectives:**

- 4. Recognition of the United States of America Republic (U.S.A.R.) as the national government of the Moorish American People within the framework of international law.
- 5. Establishment of permanent nation to nation consultation and cooperation mechanisms with relevant stakeholders and international bodies.
- 6. Restoration of traditional governance consistent with treaty rights and contemporary human rights standards.

- 8. Notify and engage relevant UN bodies and mechanisms to register the Government's status and to participate in Indigenous Peoples fora.

### **Outcome Sought:**

Mutual respect, legal compliance, and the strengthening of self-determination rights for the Moorish American People.
