**Subject: Application for Admission of the United States of America Republic as a  
Full Member State — or, in the Alternative, Observer Status**

Excellencies,

On behalf of the United States of America Republic (U.S.A.R.), I extend this application for admission as a full Member State of the United Nations, pursuant to Article 4 of the UN Charter. Should full membership not be deemed possible at this time, we respectfully request consideration for observer status in the General Assembly.

The U.S.A.R. is a clean and pure nation, free of debt, without enemies, without grievances against any other nation, and without weapons of mass destruction. We come not as a burden to the international community, but as a partner committed to peace, cooperation, and reconciliation.

We stand as the descendants of the Tribe of Judah, an ancient people whose sovereignty and nationality have endured through both divine and human law. By treaty, by international law, by constitutional law, and by divine right, the United States of America Republic must be recognized. We affirm that the principles of divine law and natural justice are binding upon nations, and that they complement the framework of international law and the Charter of the United Nations.

It must also be clearly understood that the current United States Government functions only as an interim authority. The United States of America Republic (U.S.A.R.) is the lawful transitional national government, reestablished to carry forward the sovereignty, institutions, and rights of the Moorish American People in their proper national capacity. The U.S.A.R. stands not as a dependent entity, but as a sovereign government among nations.

The U.S.A.R. offers itself as a moral compass for the United Nations and the world, committed to:

1. Peaceful Coexistence: Settling disputes through dialogue and diplomacy, never through aggression.
2. Human Rights and Human Dignity: Uplifting fallen humanity wherever it has fallen.
3. Justice and Reconciliation: Healing wounds of the past through constructive engagement.
4. Global Peacekeeping: Serving as an impartial mediator, enforcing peace and negotiating peace on behalf of the world community.

We request that our application be placed on the agenda of the General Assembly and that the Security Council consider our candidacy for membership. Should consensus be deferred, we seek immediate observer status to ensure U.S.A.R.'s presence, voice, and contribution to the work of the United Nations.

The U.S.A.R. bears no ill will, owes no obligations to any state, and carries no agenda but peace, love, truth, freedom, and justice. We come not to divide, but to unify; not to conquer, but to reconcile.

Please accept, Excellencies, the assurances of my highest consideration.
